Mr. Burrows also questioned the driveway section at 5 Knollwood and the easement with 7 Knollwood and that is the only public access to the property. Ann Marchioni of 85 Brookside thanked the council for passing this resolution. Lisa Heller of 67 Overlook Road had questions regarding the appraisal of the property. ### REPORT OF COUNCIL COMMITTEE CHAIRMEN AND MEMBERS

Councilman Mescia – Thanked everyone for their support on the vote for the resolution for the purchase of the Faloni property. Councilman Mescia reported that the Caldwell Downtown Alliance is now in the 2008 National Main Street program. Councilman Mescia reported that he attended the National Main Street Conference in Philadelphia along with Maureen Ruane. Governor Corzine was the key note speaker at the convention. Councilman Mescia also reported that April 12 is spring clean up at the Grover Cleveland Park from 9:00 AM to Noon. Anyone interested in participating should meet at the playhouse in the park. Councilman Mescia reminded everyone that April 15<sup>th</sup> is the School Board Election. Councilman Mescia reported that at the next council meeting there will be two additional resolutions on the agenda, one for Morris Land Conservancy to hire the appraisers and also to extend the contract to the end of the year for Morris Land Conservancy.

Councilman Dassing – Reported that there may be a possible volunteer for the Local Board of Assistance. Councilman Dassing also reported on The Taste of the Caldwells held last Sunday. Councilman Dassing thanked everyone that attended. Councilman Dassing reported that there may be a way for the Division of Local Government Services to perform our audit for the Borough and that it could save the Borough \$38,000.00. Councilman Dassing asked Maureen Ruane to look into this service and if it is still available to municipalities. Councilman Dassing reported that the Merchants Association would like to have a sidewalk sale on May 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup>. There would also be a Pet Day at the Veterinary Center of Caldwell on May 4<sup>th</sup>

Councilman Curley – Reported that the Public Safety Committee has asked the Fire Chief to submit monthly service call reports to the council .

Councilman Edge – Reported that the Caldwell Volunteer Fireman's Dinner will be held on April 11. Councilman Edge also reported on the Hawaiians visit to Caldwell on April 24<sup>th</sup> and 25<sup>th</sup>.

Councilman Slattery – Reported on the proclamation given to Carol Shenuski. Councilman Slattery also reported that April is Autism Awareness month and that the Caldwell Public Library has several programs going on in the month of April for autism awareness and anyone interested should call the library. Councilman Slattery also reported on a grant offered by Horizon Blue Cross/Blue Shield and asked to have Muareen Ruane and Jim Nolan of the Caldwell Community Center look into the grant.

Councilman Gates – Reported on the Transportation Committee meeting. Councilman Gates also reported that Betty Spittle, the bus driver for the Senior Citizen Bus is doing an excellent job and should be commended.

On a motion made by Councilman Curley, and seconded by Councilman Edge, unanimously affirmed, the Council moved into Executive Session in order to discuss a matter of personnel. Said motion was unanimously approved and the Council went into Executive Session at 9:25P.M.
