**Councilman Rodgers** reported that he would like to set a meeting up with the Personnel Committee to go over the evaluation forms for the employees. He thanked the Mayor for a very successful event for the Library.

**Councilman Murray** asked the Chief if he had anything he would like to talk about.

**Chief Bongiorno** reported that the Saturday after Thanksgiving the Patch will be supplying free parking Saturday for all the merchants from 10AM to 2PM. The Patch will pay the Borough for what it would cost per meter for four (4) hours.

**Councilman Kelley** also spoke about the wonderful job that the Mayor did at the Gala.

**Mayor Dassing** thanked everyone who attended the Mayors Legacy for Literacy including the table of staff. We appreciate everyone's support it was a very nice evening. The synergy between Governor Kean and Governor Cody was something that you don't see everyday between that and seeing our youth singing it was a very memorable evening. The Library Director said she feels that the library staff, the library board and the library foundation all know how important that the

Library means to the Community but to hear Governor Kean say it in such an eloquent manner helped us to reaffirm that what we were doing was the right thing.

The Park Avenue application is in and it has been received I have confirmation from the Federal Government. They are reviewing it and hopefully we answered all the questions correctly. I did see Stan Brown who runs the Bridge today and they are very appreciative, the Bridge, which we have gone to bat to keep the building.

The Caldwell Merchants Association is running a holiday treasure hunt on the Saturday after Thanksgiving the 24<sup>th</sup>. The quest is to find the Holiday gnome. There are tally sheets at Caldwell Flowerland from 10AM – 2PM. Once you find all eight gnomes you go to the little hut on the corner of Park and Bloomfield to receive a holiday prize.

**Councilman Coyle arrived at 7:14PM.**

**REPORT OF ADMINISTRATOR:**

**Paul Carelli** handed out pictures to the Council of the water main break Friday morning at Caldwell College. This is the 12” water main that we have spoken about and this was one of the main reasons we were doing the Brookside job to close the loop of water. They were able to fix it without turning off the water if that was required 80% of the town would have been without water. This is a temporary fix and Bill Frint is working up a proposal he does not want to wait for the Brookside interconnect. **Councilman Coyle** asked what is the target date for completing this fix, permanently. Paul responded he has not given a time frame and he will find out. In the month of December we place bags over the meter and I am looking for direction for time frame. Suggestion was made that the bags that are bought say three (3) hour parking.

Paul will touring with Hunter from Broheimer to look at the Elm Road property and Faloni property. We currently have \$4,000 in our shade tree budget that I can use to take care of the trees. I would like to get a proposal to do everything and be done once and for all. We are able to use our Open Space Trust Fund and I would like to utilize that as well. Discussions Ensued.

Moved by Councilman Coyle, seconded by Councilman O’Donnell. Discussions Ensued. On roll call, all present voted in the affirmative. Resolutions approved 11/20/12.

Paul spoke about the Recycling contract. The current contract we pay is around \$105,000 for pickup and we get money back so the net cost for recycling is in the neighborhood of \$65,000 per year. Glen Beckmeyer has been doing some research and he wants to do a change order for our garbage contract. Typically if you stay at 20% of the total amount you can do that. Greg Mascara responded that there would be an amendment to the existing contract. It has to be in the scope of the original service. Discussions Ensued.

We did an RFP on Financial services and we received three quotes. It will require a meeting with the committee. We had our auditor in last week and we went over budget and she was pleased with everything. They will be coming in on December 14 and 17th to start doing the year end.

**Councilman Hauser** asked if we had a figure on the FEMA dollars. Paul responded the last calculation was \$85,000.

**REPORT OF ATTORNEY:**

**Greg Mascara** reported that there is an ordinance that is not on the agenda. I spoke with Chief Bongiorno and he advised me that we got the approvals back from the County in regards to the fines and one of the fine schedules has \$35.00 as a minimum. We had to amend the ordinance because of the way it was written it stated a \$50.00 minimum, so we replaced it with \$35.00. The second thing that is on Old Business is a draft ordinance that I was asked to prepare in regards to prohibiting Borough Employees from using the Borough email system or equipment for political purposes. With regard to the property on Kirkwood that was torn down because it was demolished there is an issue with the tax lien that had been on the property. So what the Borough has to do is buy that lien back. The good news it can be sold at the next tax sale in December. Ida has

indicated that she has received a lot of interest in that sale. We are making progress on the Sewer agreement and there is no substance that needs to be brought to executive session. In regards to the progress of the Knights property, we are continuing to move along we did have to get a second appraiser. The good news is it appraised for too much but the bad news is because it was appraised for more than \$200,000 the Green Acres requires a second appraisal. The other good news is there is a chance we will get reimbursed for 50% of the appraised amount not just 50% of the contract amount. We are hoping to close by the end of the year. In regards to resolution 11-246, I met with Judge O'Connor and there is a rather strict procedure before a Court clerk can be hired. The person has to be approved by the County before the Borough can approve that person. Discussions Ensued.

**Councilman Hauser** asked the question to Greg Mascara, what is the next step for this ordinance that you drafted. **Greg** responded that we drafted this ordinance so there can be a discussion prior to the first night of introduction so this was provided for discussion. **Councilman Hauser** asked Councilman Kelley if he was still looking to push for this. **Councilman Kelley** in terms of Borough email and Borough assets, yes I would hope we are all in agreement to it; it's something we should be doing. **Councilman Hauser** asked Councilman Rodgers what are your thoughts, are you in favor of pushing forward with this. **Councilman Rodgers** responded sure. **Councilman Hauser** asked Greg Mascara the question; since the two gentlemen are in favor of pushing this forward would it be appropriate to add to this that town property should not be used for furthering political interest as well. **Greg** responded that we can do that as well. **Councilman Hauser** responded just to be clear Kiwanis Oval and property on that would fall under that jurisdiction correct? **Greg Mascara** responded absolutely. **Councilman Hauser** responded that I think that is important that we include that. I have some pictures of Councilman Rodgers having signage up on the sheds of the last couple of years pushing for his election. I find it a bit ironic that this was presented with that left out of the mix. I think it is appropriate that town property be added in the mix. **Greg Mascara** responded that Mr. Hauser in the personnel section that probably is a violation. There is a section D2 that states an employee shall not engage in political activities during work hours. There was something else I was looking for that an employee or officer should not use Borough property for their own gain or benefit. I think that might be covered and it might be a violation of the policies that we have. **Councilman Hauser** responded that if it is appropriate to add it I would suggest adding it. **Greg** responded that if it is a violation of policy then I would address it with Councilman Rodgers. **Councilman Hauser** responded that I believe it has been rectified I have some pictures of that signage that is up if the media or anyone else that is interested. **Councilman Rodgers** responded I believe it was an old sign two elections ago and it was upside down and it was placed there by one of my helpers to block the window. **Councilman Hauser** responded it's not upside down or sideways. **Councilman Rodgers** responded just like the Norton Piazza sign that was in the Community Center window perhaps. **Councilman Hauser** responded Frank I didn't bring this up. **Councilman Rodgers** responded at least that one was from two elections ago and it was never up there during election. **Councilman Hauser** responded if you live in glass house don't throw stones Frank. **Councilman Rodgers** responded who said I threw stones. **Councilman Hauser** responded who said you don't throw stones? The whole fiasco that the two of you brought up a month ago is what started this whole thing, its ridiculous. **Councilman Rodgers** responded using the Borough email on your campaign website. **Councilman Hauser** responded Frank you used the Borough shed on your campaign so how is that different. **Councilman Rodgers** responded that you went ahead to the Cedars after the meeting so you really don't care about it anyway. Like I said that sign was not up during the election. **Councilman Hauser** responded great even better it was up for several years, even better. **Councilman Rodgers** responded it was not up for several years it probably went up last spring and like I said I didn't put it there it was a left over. Is it there now? **Councilman Hauser** responded ironically it was taken down shortly after the whole fiasco was brought up. **Mayor Dassing** responded Greg you are going to take a look at the use of town property for political signage and we will add that so we are thoroughly complete with this ordinance.

I believe this is something that should be addressed and I will put it on my too do list.

**ORDINANCE# 1269-12**

**AN ORDINANCE AMENDING CHAPTER 20, THE CHAPTER ESTABLISH THE CODE OF ETHICS, OF THE CODE OF THE BOROUGH OF CALDWELL**

**BE IT ORDAINED** by the Council of the Borough of Caldwell as follows:

That Chapter 20 of the Code of the Borough of Caldwell, New Jersey be amended as herein set forth:

That Chapter 20, Section 3, of the Code of the Borough of Caldwell, the Section titled "Standards of Conduct" is hereby amended as follows:

1. That existing subsection G be deleted and replaced as follows:

G. No local government officer or employee shall:

(i) use, or allow to be used, his or her public office or employment or any information, not generally available to the members of the public, which he or she receives or acquires in the course of and by reason of his or her office or employment, for the purpose of securing financial gain for himself or herself, any member of his or her immediate family or any business organization with which he or she is associated;

(ii) use Borough real property and/or personal property for private or political use;

2. All Ordinances of the Borough of Caldwell which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.
3. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.
4. This Ordinance shall take effect immediately upon final passage, approval and publication as required by law.

That Chapter 37, Section 3, of the Code of the Borough of Caldwell, the Section titled "Employment Practices" is hereby amended as follows:

1. That existing subsection 3E be amended by adding the phrase "and by the Department Head to whom the employee will report" after "Administrator" at the conclusion of the first sentence. The amended Subsection E shall now read as follows:

All applications received by the Administrator shall be reviewed by the Administrator and, if applicable, by the Department Head to whom the employee will report. Those applicants who appear to be most qualified shall be interviewed by the Administrator. During the interview, the applicant shall be apprised of the borough's personnel policies, terms and conditions of employment, duties of the position, benefits and other appropriate information.

2. That existing subsection 3H be deleted and replaced with the following:

The Administrator shall have the authority to, and shall, fill a vacant position after having considered all of the applicants in the manner set forth in this section. Despite the foregoing, the Mayor and Council, and not the Administrator, shall act to fill a vacant or new position for a Department Head after having received and considered the recommendation of the Administrator.

2. All Ordinances of the Borough of Caldwell which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.
3. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.
