COMMENTS BY MAYOR AND COUNCIL

Councilman Cole

To the Mayor, Council Members, Guests and Caldwell's residents.

This has been quite a year! I've been trying to find words - a brief statement for this evening - as the spotlight tonight is on our returning Councilmen; Henderson Cole and Jonathan Lace. Thank you for stepping up once again to serve our community. Your intelligence, insight and experience are an asset to our municipal governing body. I'm honored to be here with you. This has been a year with challenges that our nation has not seen in over a century. As the Coronavirus spread, we had new questions to answer and hard decisions to make. Faced with an unprecedented health crisis, we turned to our very own OEM team, our Health officer, our police chief, our Borough Administrator and of course our Mayor. We have looked for parking solutions, settled builder's remedy lawsuits, and, finally came up with a plan to put Caldwell on the right track for Affordable Housing and redevelopment. We faced new challenges. We have updated ordinances, held a peaceful protest, resolved to fight racism and resolved to support our police (the two are not mutually exclusive). Our library has responded by providing resources to learn about the issues of the day and they have increased their access to digital materials during the long days of a lockdown. Our DPW has been disinfecting first responder vehicles and they put up barriers so our restaurants could serve their patrons outdoors. We put up curbside pickup areas along Bloomfield Avenue so we could continue to enjoy our favorite restaurants and support our local businesses. We look forward to the day we can all sit together at a table. There have been Mayor's calls, OEM calls, County calls, BOH calls, and we've learned to look our best during Zoom meetings and we're getting better at unmuting ourselves.

One of the positive changes is that many residents have attended our virtual meetings. There are lessons to be learned about widening participation and it will be interesting to find a way to continue virtual attendance even once we return to Council chambers. In spite of the lock downs, we have found a way to work together, communicate and get the job done.

To close, I want to thank you to all of you who work for the Borough who have kept on keeping on. Thank you to our residents; those who support and encourage as well as those who disagree and make us do our research and due diligence. Thank you to my family who has picked up all the slack at home while Council has become a full-time job. Lastly, please, during these difficult times, be kind to each other - be kind to yourselves and remember that together we are a work in progress
